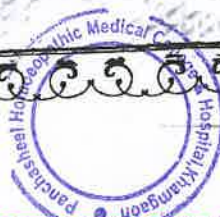

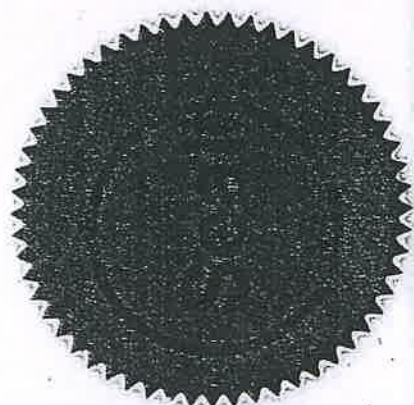

Panchsheel Homoeopathic Shikshan Prasarak Mandal's Homoeopathic Medical College, Maharashtra is functional since 1993 and has applied for permission for sanction of BHMS course with intake capacity of 100 seats and 15 seats in PG (Hom) in 05 PG departments namely Homoeopathic philosophy, Materia Medica, Repertory, Paediatrics and Practice of Medicine with 03 seats each for the academic year 2024-25. The College Part 1 information has been received for information on compliance to MSR 2013. The Medical Assessment and Rating Board has examined the profile of the College as to whether the college fulfils the Minimum Standards Requirements to be fulfilled as per the prevailing regulations under clause 28 of NCH Act 2020.

On careful examination of the report, the Medical Assessment and Rating Board has observed following shortfall.

1. Miscellaneous

- Attendance and acquittance of guest faculty is not uploaded. College shall submit copy of the attendance and acquittance of guest faculties of last 3 months.
- Attendance and acquittance of modern medicine consultant is not uploaded. College shall submit the attendance and acquittance of last 3 months.

2. Hospital details

- IPD and OPD case records should be maintained with demographic details of the patient such as Name, Age, Sex, Address, Phone number, etc. Diagnosis of the case shall be recorded as per ICD 11 criteria. All follow up attendance should be recorded on the case records. Case sheets shall be maintained with complete case history, analysis, evaluation and repertorisation and made available in Medical Record Room for academic purpose of students and follow up of patients.

Considering the above observations and facilities available, MARBH has decided to issue Conditional Permission to Panchsheel Homoeopathic Shikshan Prasarak Mandal's Homoeopathic Medical College, Civil Lines, Kelanagar, Khamgaon-444303 for conducting BHMS course with intake of 100 seats and 15 seats in 05 PG departments namely Homoeopathic philosophy, Materia Medica, Repertory, Paediatrics and Practice of Medicine with 03 seats each for the academic year 2024-2025.

All deficiencies noticed shall be rectified within a period of one month and the compliance report shall be submitted for verification.

It is further to mention that all admissions shall be made from NEET/AIAPGET qualified candidates only. It is further informed that minimum 15% of undergraduate seats and 15% of postgraduate of the permitted intake capacity of 100 UG seats and 15 PG seats shall be treated as All India Quota. Counseling for seats under all India quota shall be conducted by respective Counseling Authority of State/UT govt as designated by Central Government and counseling for the remaining 85% seats or s the case may be, shall be conducted by the concerned counseling authority of the state/UT.

The Category wise list of the selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET/ AIAPGET qualified students will not be approved by the Medical Assessment and Rating Board.

Permission to college can be withdrawn or denied in the subsequent year if college is found deficient in compliance to MSR 2013 anytime during the academic year.
